2008

ConServ Building Services agreed to service Target stores in Atlanta, GA, officially expanding outside of Florida. The CBS-Target relationship has since expanded to 492 locations throughout the southeast.



BURNHAM INSTITUTE AT LAKE NONA

BCH was selected for the Amway Center (Orlando Magic) and the Burnham Institute, a 3-story, 178,000 sq. ft. project, at \$16.2M, our largest lab/ clean room at that time.

2011

ConServ purchased Bradford Mechanical, in Houston, expanding into Texas and reached a record \$20M in revenue, contributing to BCH's annual total of \$62.8M. BCH obtained Charter Schools USA contract for Winthrop Charter School in Riverview, with Ryan Companies. ConServ now performs the controls, test & balance, commissioning, and service for their facilities throughout the southeast.

2013

BCH was selected for the Eckerd College CMLS project; USAA, a 466,000 sq. ft. new facility; and the \$4M University of Tampa Residence Hall, one of several projects with UT and Beck Construction.

2014

ConServ purchased Florida Pro Air, in Jacksonville, FL. Owner Phil Tanner stayed on as branch GM. ConServ exceeds \$35M in sales revenue, a 75% increase in 3 years. Mike Sherron, Sheet Metal Coordinator overseeing roughly 150 men, celebrated his 20th anniversary with **BCH**.



2015

BCH was contracted for Lakeland Regional Medical Center, at \$33M, our largest project to date.

ConServ purchased Cool Air Solutions, in

Nashville, TN, as well as Marshall Mechanical in Richmond, VA. Dave Smith and Johnny Pritchett stayed on as GMs.

BCH earned record revenue of \$98.6M (\$38.35M from **ConServ**), a 57% increase in 4 year's time.

2009

ConServ purchased Anytime Heating and Cooling out of Atlanta, GA, and officially established ConServ of Georgia. Robert Blalock, one of the original owners, stayed on with the new entity and has guided our Georgia presence since.

BCH secured USF Visual Performing Arts, one of several projects for University of South Florida, including Magnolia Hall Dorms, over the next few years.



2010

ConServ purchased RP Heating and Cooling, in Charlotte, NC with Jason Morris guiding ConServ of NC with phenomenal growth. BCH performed the Nemours Children's Hospital project in Orlando, with Skanska.

2012

ConServ purchased Stillwater Refrigeration and Construction, in Piedmont, AL, with owner Bob Holbrooks remaining on as General Manager. BCH contracted for the Sarasota Memorial Hospital Patient Tower, a \$10.6M project with Skanska. We also began our relationship with RC Stevens and have performed multiple Coca-Cola facilities with our industrial mechanical division.

ConServ purchased V-tec Mechanical, in Dallas, TX. Owner Justin VanVleet remained to oversee operations. BCH secured the contracts for Winter Haven Hospital for \$8M; Raymond James Stadium for \$4M; and Grand Living for \$6M—our largest design build project to date. Jesse Moody celebrated 30 years with BCH. He has guided our

sheet metal shop from manual operation to automation, producing 4M+ pounds of metal per year.
